Vince will call contractor to try to reduce cost of Gail McClain's proposal, seeking 10% reduction

Vince will inquire as to the boulder size contemplated in the plan.

Resignation of President Steve Solomon due to Steve's pending move from the neighborhood was approved.

Eddie Croy was approved as a Board Member to serve our remainder of Steve's term (until Dec 31, 2015)

Motion to make Bill Daniels President was approved

Motion to make Mike DeSantis Treasurer was approved
